PROJECT KEY OBJECTIVE

- -Safety rules are disseminated in induction trainings and posted on sites.
 - -Daily safety patrols by site managers and safety personnel.
 - -Submission of reports on the results of safety rule implementation inspections (twice a month).
 - -Implementation of repetitive training through use of safety rule videos.
 - -Submission of safety pledges by subcontractors.
- -Establish priority control items in accordance with the operations (every week).
 - -Designate a person in charge and strengthen guidance (weekly duty system).
 - -Reporting and dissemination of information on the status of activities at each site in monthly reports and at meetings.
- 3. -Enforcement of the "Stop the fall accident checklist" and reporting.
 - On-site all-round patrols: inspection of workplaces by all relevant personnel, including workers (22nd of every month) and report back.
 - -Implement experiential training (e.g. use of harnesses, insecure working floors, etc.).
- 4. -Thorough enforcement of no-entry measures.
 - -Ensure proper deployment and training of guides.
 - -Thorough implementation of pre-work inspections.
 - -Thorough preparation and storage of inspection records.
- 5. -Participation in monthly progress briefings in each country to make recommendations on pending issues.
 - -Identification of key issues to be checked in accordance with the type of work.

- -Dissemination of past cases and reports of quality defects, and implementation of training.
 - -Continued education and training jointly organized with MMOM (monthly).
- 7. -Clarification of duties of PMS Department, the Global Business
 - -Strengthening the organization of the PMS teams in each country.
- 8. -Internal audits are carried out at least once a month at each site.
 - -International audits are carried out twice a year in each country (three sites and an office each time).
 - -Expand the number of participants by holding audit summary meetings on web.
 - -Safety Day: Raise safety awareness through webcasts to all workplaces in each country.
- 9.
 - -Preparation and implementation of environmental activity plans for noise, vibration control, construction drainage treatment, air pollution control, waste disposal, and energy saving, etc.
 - -Introduction and encouragement of activities in monthly reports and at monthly meetings.
- -Initiatives for the Green Challenge 2030
 - Raising awareness and conducting educational activities for SX initiatives.
 - -Examine, plan, and execute specific reduction measures that can be implemented overseas. (Efficient operation of C-turtle and accurate measurement of CO2 emissions, as well as planning and execution of CO2 reduction measures)
